CC still does not reply to VH but sends solicitor's letter demanding keys, documents, bank accounts .. Then changes  
 Hall door locks and places accusatory notices in public. VH notes CC new errors etc .. Makes public 'Statement'

March 2021 .... See box above

April 2021 ... request on Defibrillator pads .... No reply

May 2021 ...polite request for key to restart classes  
 CC refuses .... VH committee resigns
